### **Lost But Not Forgotten**

#### **Douglas Marion Pulliam (1921-2013)**

Douglas Marion Pulliam (F/20th and C/1340th) died January 31, 2013, at 91 in Weatherford, Texas, after a stroke on August 2, 2011. He was born September 28. 1921, in Gatesville, Texas. Doug and your Wavy Arrow editor took basic training during early 1943 at Fort Leonard Wood, Missouri, and we earned Sharpshooter Badges as Doug proudly recalled. We were then picked to depart April 17, 1943, aboard the HMS Andes along with 3,000 U.S.troops from every branch of service for a four-and-a-half day hazardous voyage from New York to Casablanca, out-running U-boats. U.S. troops and desperately needed military equipment was needed to replace the losses to Erwin Rommel's Panzer Tanks. After a ten-day train trip on Forty & Eight box cars, we joined the 20th Regiment near Bizerte, Tunisia, On July 10, 1943, we invaded Sicily after which we were shipped to England to become 1340th Combat Engineer Battalion for the Normandy invasion at Omaha Beach.

Doug was wounded on November 4, 1944, in the Hurtgen Forest. After the war, Doug married Patsy Ruth Daugherty on March 19, 1949, and had five children. Doug and his brother Doren established Pulliam Incorporated, did concrete work, and built swimming pools He also maintained the 60 acre farm in Weatherford. Doug participated in the 1993 20th Tour which featured the installation of a 20th Engineer plaque on Omaha Beach. He also attended many of the 20th Reunions, and was accompanied at the 2004 final Reunion by his daughter Lea Crow and his grandson Joshua Hankins who reported at the time "we now both have a much greater appreciation for the accomplishments of the 20th Engineers during World War II." Doug enjoyed playing pool at the Senior Citizen's Club and corresponding with his Combat Engineer buddies. After a funeral at the Greenwood Chapel, Douglas Pulliam was interred at the Greenwood Memorial Park in Fort Worth. His widow, Pat, and his daughter, Lea Pulliam Crow, provided information for this obituary.

#### **Joseph Herbert Kleinfeld (1920-2013)**

Joseph Herbert Kleinfeld (E/20th; H&S/1340th) died January 10, 2013, in Tamarac, Florida. He was born April 23, 1920, and he joined Company E, 20th Engineer Combat Regiment, landing in North Africa, November 9, 1942. Company Commander Thomas Creegan transferred Joe to H&S/20th for the invasion of Sicily, July 10, 1943. While in England, the 20th Regiment was split into two Battalions, so Joe spent the rest of the war with Company B, 1340th Engineer Combat Battalion. After he was discharged at Fort Dix, New Jersey, in 1945, he married Sylvia with whom he had two children. He opened the Craig Shoe Shop at 114 Chambers Street in New York City. In 1952-1953 he served as Secretary-Treasurer of the newly formed 20th Combat Engineers Association. In 1953 the Wavy Arrow published a photograph of Joe with his two-year-old daughter Carol and his five-year-old son Steven. In 1974 the family moved to Elmont, New York, and soon thereafter to their final home at 7030 N.W. 107th Avenue, Tamarac, Florida. Joseph Kleinfeld is interred in Long Island, New York, next to his wife, Sylvia, who preceded Joe in death.

In a similar fashion, William J. Howard, 15320 Shady Oaks Drive, Stagecoach, Texas 77355, is trying to learn more about his uncle, Archibald Howard, who was assigned in England to Company C of the 20th Combat Engineer Battalion. These are just two examples of an increasing number of sons, daughters, and family members are trying to learn more about the World War II experiences of 20th and 1340th veterans.

# Miller L. Petty (1917-1990)

We haven't published biographical information on Miller Petty (D/20th, A/1340th) until now when his widow, Kathleen Petty, provided the following details. Miller (nicknamed "Doc") was born September 28, 1917, in Charlotte, North Carolina. He enlisted in the Army

in February 1941, and was assigned to Company D, 20th Combat Engineer Regiment. After his marriage to Kathleen in May 1941, he participated in the November 1942 invasion of North Africa and the July 1943 invasion of Sicily. He then sailed to England where his unit became Company A, 1340th Combat Engineer Battalion for the June 1944 invasion at Omaha Beach in Normandy with the rank of T/5. Like many of his comrades, Miller was wounded in the Hurtgen Forest. After the war he worked for the Seth Lumber Company in Lincolnia, and later served as the shipping supervisor for Thrift Dye Works in Charlotte, North Carolina, retiring in 1982. Having been away for four-and-a-half years, he was very possessive of the time he spent with his family, including daughter Dana, as if making up for the lost years. Miller died July 1990 and was interred at Gaston Memorial Park in Gastonia, North North Carolina. Kathleen Petty who lives at 795 Stanley Mountain Road, Gastonia, North Carolina, 20865

added the following touching story.

One day in 2012 my great granddaughter went to the post office in Sanford, North Carolina, wearing a shirt with the logo for the Spencer Mountain Fire Department. An elderly man approached her telling her that he lived there before the war. She explained that her Great Granddad, "Doc Petty" also used to live there. The elderly man was astonished and explained that he and Miller fought together in the Hurtgen Forest where Miller had saved his life. He hugged my granddaughter and told her "I would not be here today were it not for your grand daddy." Unfortunately my granddaughter did not get his name but it was a blessing to hear of this incident.

#### **Widow Assists Senior Citizens**

Neysa A. Miller, Widow of Frederick Miller, H&S/20th, writes, "I am O.K. but I miss my Fred and all of the wonderful 20th Reunions. I am now involved in developing a new service center for senior citizens of Westminster. Massachusetts, which keeps me busy and out of trouble. With the support of the board of Council on Aging and the building committee on which I serve as a member of both, a vote of the township authorized construction of a senior center with patio, a game room, an exercise area, and a kitchen with free groceries. We break ground in April 2013, and if all goes well, it should be completed by the Spring of 2015." (Editor's Note: Frederick Miller served as secretary-treasurer of the 20th Combat Engineers Association from 1989 to 1996. Neysa and Fred hosted the 1985 Reunion in Jackson, New Hampshire, and after Fred's death in 1999 she continued to assist with the registration at several other Reunions, and attended the final 2004 Reunion in Washington, D.C.

# **Death of Several Widows**

Elizabeth Doherty, widow of Henry R. Doherty (A/20th Officer) has died according to her children. Their father, Captain Doherty, died April 16, 2004.

# New Information on 20th & 1340th Veterans Now Available

Your editor has compiled an 18-page list of all known veterans of the 20th and 1340th by company with data on those who were wounded, taken as prisoner, and killed in action. The 20th saw action from November 9, 1942, to August 6, 1945. A total of 234 veterans of the 20th were wounded, 28 of whom were wounded twice, and three wounded three times. Forty-eight were wounded in North Africa; seven in Sicily; 79 during the Normandy invasion; 20 in France, Belgium and Luxembourg; 91 in the Hurtgen Forest, and 22 from the Rhine to Czechoslovakia. Half of those wounded were not able to return to the 20th for additional action. Twenty-eight were POWs, mostly taken in the Hurtgen Forest. Forty-two 20th veterans were killed in action; six in North Africa; 12 during the Normandy invasion, and 19 in the Hurtgen Forest.

The 1340th saw action from June 6, 1944, to August 6, 1945, but no dates for the wounded are available. A total of 195 veterans of the 1340th were wounded including seven that were wounded twice, and four wounded three times. There were seven POWs, and a total of 29 were killed in action with 25 of them taking place in the Hurtgen Forest.
